#### **Community Reaction to New Library:**

(quoted from the NC State Library Blog)



119 people (or 1% of the entire county's population) came to the soft launch opening of the library on July 1, including Representative Bob Steinburg from North Carolina district 1. So far, the community's reaction has been great. People are very excited to have their own library in the county. In the first week of the soft launch alone there were 398 visitors (4% of the county's population) and about 15% of the entire collection was checked out. A full quarter of the juvenile fiction materials were checked out in the first week. "We are very proud and excited. The reaction has been tremendous," said Mike Renshaw, Camden County Manager.

The library's hours are: Monday through Thursday from 10AM - 7PM, Friday and Saturday from 10AM - 5PM, Closed Sunday.

#### Services offered by the library include:

- Helping patrons find the right book, item, or information using the library's in-house collection and online resources such as NC LIVE
- Helping patrons with technology needs such as computers or devices such as eReaders, tablets and smartphones.
- Provide homework and research help for students of all ages.
- Printer, fax, copier service (fee applies). Interlibrary Loan outside of region (fee applies).
- Inter-Library Loan through the 8 member libraries of the East Albemarle Regional Library (EARL) System which includes all public libraries in Camden, Currituck, Dare, and Pasquotank Counties. A courier service runs between the different libraries several times per week.
- Reading, education, cultural, and technology programs for children, teens, and adults, including story times for babies and toddlers.

There will be a ribbon cutting ceremony held on August 5, 2013 at 11:00 AM Come Join Us At The Library!

#### **Camden County Tax Department**

This is a particularly busy time of year for the Tax Department, tax bills will be going out in September, vehicle taxes will be coordinated through the DMV, and a county wide revaluation is under way. Below is more information on each of these.

- 2013 Tax Year Bills to be mailed in August
  - o Due on September 1, 2013
  - o Grace Period: 9/1/13 through 1/5/14
  - Payment Plans Available Call Tax Department for more details
- September Vehicle Tax / Tag Renewals
  - o Taxes will be through DMV to coincide with registration renewals
  - More Info on this change: www.ncdot.gov/dmv/vehicle/tagtax
  - Tax Department still responsible for bill information, and processing values & situs which are then forwarded to DMV
- County Wide Revaluation
  - Goes into effect January 2015
  - Appraisers will soon be checking each property
    - Will have identification with them and be in signed vehicles
    - If in doubt about any person on your property, call the Tax Office for verification of identity. If on weekend, call Sheriff's Office.

#### **Mandatory Standards for Land Disturbance Activities**

#### New Requirement: Fill Permits

On March 18, 2013 the Board of Commissioners passed Ordinance 2012-12-01, an amendment to the Unified Development Ordinance which created Article 151.404 (Mandatory Standards for Land Disturbance Activities).

This amendment created requirements on the amount of fill a person can place on their lot without affecting adjacent properties as far as stormwater runoff. The standards shall apply to any application for a building permit where land disturbing activity is proposed and the placement of fill is being utilized on the lot.



In cases of natural grade differences greater than nine (9) inches between adjoining lots, the County may require (based on the size and shape of lot) a stormwater management plan prepared by a North Carolina licensed engineer, land surveyor, or landscape architect reflecting that the proposed development will not create flooding or nuisance conditions on the lower lots.

This newly enacted ordinance created the requirement for a "fill permit" which must be obtained in advance of any building permit wherein fill may be utilized.

This new requirement is intended to protect those properties adjoining any project wherein fill is proposed from the possibility of excess stormwater runoff and flooding. After receipt of an application for fill permit, the flood administrator reviews the property to determine if the proposed fill will or will not adversely affect any adjoining properties and then either approves or denies the fill permit accordingly.


## Building a House? Improving a Rental Property? This New State Law Affects You...

Effective as of April 1, 2013, state legislators have enacted a new law requiring the appointment of a "Lien Agent" when building a new home or renovating a rental home, be it a stick built house, modular, or mobile home. Any property improvement project that is over \$30,000 in retail cost requires a Lien Agent

to be appointed with the following 3 exceptions: (1) If the improvement project is to take place on or in an existing home <u>and</u> if the homeowner is the current resident of the home then no lien agent is required; (2) If the project being undertaken is less than \$30,000 in retail cost no lien agent is required; (3) If the project being undertaken is under contract and that contract is dated prior to April 1, 2013, then no lien agent is required. The table below summarizes when and if a lien agent is required:

If you are a builder and you have a contract to build a house, and that contract is dated prior to April 1, 2013 you are exempt from the requirement only for that project for which you have a contract as described above. An exemption form and copy of the contract are required. Contact the Planning Department for the appropriate form.

#### **One Mill Park**

# Project Update

As reported in the April newsletter, the County applied for two grants to assist in acquiring a 2 acre parcel & constructing a small park with an improved boat ramp and parking area at the end of One Mill Road. The total project cost is \$580,479 and includes the following:

- · acquiring the property
- demolishing all existing structures (house and workshop buildings)
- replacing an old boat ramp
- replacing approximately 315 feet of dilapidated bulkhead and riprap
- constructing a boardwalk along the river
- constructing a new pier
- installing a playground
- constructing a parking area designed to accommodate cars with boat trailers
- developing a pavilion and picnic shelters
- constructing a bathhouse/restrooms with outside showers
- connecting the elements with a sidewalk.

We received notice in July that the North Carolina Parks and Recreation Trust fund has approved a grant for this project and will provide \$290,240 (50%) of the funding. Although we are still waiting to hear if our application for an additional \$139,000 from the Coastal Area Management Agency will be approved, staff is proceeding with property acquisition and other initial steps to get this project underway. The county has three years to complete the project.

#### **Stormwater Management & Utility Fee**

#### **Update**

In July 2013, the Camden County Board of Commissioners held public hearings regarding stormwater management. They subsequently voted to approve an ordinance establishing a stormwater program, and fee, to conduct clearing & snagging maintenance activities on major streams and ditches located within the county, and perhaps some dredging where permitted by the Army Corp of Engineers. The objective of the stormwater program is to keep the downstream and forested areas clear of debris which impedes the free flow of stormwater drainage. Property owners and NCDOT will still be responsible for maintaining roadside ditches, farm ditches & canals, and other ditches on their property.

The program will be guided by Stormwater Advisory Committees appointed by the Board of Commissioners in each of the County's four (4) watersheds. They will identify key areas for maintenance activities each year, recommend the annual budget, and oversee the program. Soil and Water Conservation staff will actually conduct the daily operations, and Planning staff will assist with administrative activities.

In order to pay for the program property owners will pay a Stormwater Utility Fee, which is based on the size of their property & the amount of impervious surface(s) on their property (rooftops, driveways, parking areas, storage buildings, barns, etc.). Since the payment is that of a fee rather than a tax, no properties are exempt; however the method of billing and collections will be through a new entry on each tax notice.

The fee rates will differ in each of the 4 watersheds, and the revenues generated will only be used for stormwater management related activities taking place within each respective watershed. At the time of this writing, the actual fees have not been finalized. However, once finalized, they will be in the range of \$35 (for single family homes situated on less than 2.5 acres), and up depending on total acreage and impervious surfaces, to \$110 for a farm of 100 acres or more. The Board of Commissioners are currently considering minor changes which will address concerns raised at public hearings. They hope to finalize the rates in early August in time for inclusion on this year's tax notices.

The Dismal Swamp Canal is 22 miles long with locks at each end, in South Mills, NC & in Deep Creek, VA. The canal is a no wake zone. The Army Corps of Engineers maintains the canal with a controlling depth of 6 foot and the locks operate four times daily.

Our three mile paved trail is a boundless place to hike, bike, bird watch, or take photos. Butterflies and Dragonflies are abundant. 
