A LOCAL STATE OF EMERGENCY IS IN EFFECTIVE FOR PASQUOTANK AND CAMDEN COUNTIES AND THE CITY OF ELIZABETH CITY, EFFECTIVE 8:00 AM, MARCH 17, 2020

• As of 4 April 2020, CDC now recommends the use of cloth face coverings in community settings to help reduce the spread of COVID-19.

Governor Cooper issued Executive Order 117 which prohibits the mass gathering of more that 100 persons in a single room or single space at the same time and the statewide closure of k-12 public schools to limit the spread of COVID-19, effective March 14, 2020. Governor Cooper announced that NC restaurants and bars will be closed to sit-down service and limited to take-out or delivery orders starting at 5 pm, March 17, 2020. Full Executive Order 118 can be viewed at: https://files.nc.gov/governor/documents/files/EO118.pdf

Governor Cooper has issued an Executive Orders facilitating critical motor vehicle operations and delegating authority to the Secretary of the Department of Health and Human Services to waive regulations in order to expand access to child care and support local health departments. Governor Cooper has issued Executive Order 120 which bans crowds of more than 50 people and requires certain businesses to close, such as movie theaters, hair salons, health clubs, etc. It also extends school closures statewide to May 15, 2020 and limits visitors to long-term care facilities. Governor Cooper has issued Executive Order 121, a statewide Stay at Home Order beginning Monday, March 30, 2020 at 5 p.m. until April 29, 2020, directing people to stay at home except to visit essential businesses, to exercise outdoors or to help a family member. Specifically, the order bans gatherings of more than 10 people and directs everyone to physically stay at least six feet apart from others. Governor Cooper issued Executive Order #122 was issued on March 30th which eases regulations on the disposition of State Surplus property to help schools and local governments to bridge the gaps during COVID-19 response. This order also provides for the transfer or donation of PPE and other healthcare supplies from State Government ot the State's Health Care Coalitions. Executive Order #125 was issued on 1 April 2020. EO #125 authorizes and encourages remote shareholder meetings during the COVID-19 State of Emergency.

A Request for Donations of Personal Protective Equipment (PPE) from private businesses and the public was posted on Facebook Thursday, March 26th. We have been receiving donations in and redistributing them out to Sentara Albemarle Medical Center and other health care agencies as needed. We pushed out an additional request on April 1st for goggles and face shields as this is a critical need for our local health care providers. **Donations of gloves, gowns, Tyvek suits, N95 masks, hand sanitizer, disinfectant products, etc. are still needed!**

<u>Medical Volunteers are needed.</u> Registration for disaster medical volunteers is available within the NC Emergency Management Training, Exercise and Response Management System (TERMS) to register disaster medical volunteers. As of April 6th, over 2,100 individuals have registered to be medical volunteers to provide support, and are currently being vetted prior to assignment. 971 personnel have been approved to date. Pasquotank County is interacting with the public by appointment only starting at 8am, Tuesday, March 31st for departments located in the Pasquotank County Courthouse (County Manager's Office, Finance Office, County Attorney's Office, Planning and Inspections, Human Resources, Clerk of Court and Magistrate Office) and Register of Deeds/Tax/GIS Office to limit face-to-face contact for business that cannot be conducted via online services, email or telephone. The <u>Pasquotank County Board of Elections</u> is closed to the public, effective March 20, 2020 at 12:00 pm until further notice. The normal duties of the office will still be administered and all staff will be available by phone or by email.

The Pasquotank Landfill Convenience Site will have a change in operating hours effective Saturday, April 4^{th} . Monday – Friday 7:00 am – 4:30 pm. Saturday 7:00 am – 12:00 noon. Closed Sunday. All other convenience Sites will be operating regular hours.

The <u>Pasquotank Library</u> will be closed to the public beginning at 6:30pm Monday, March 16th until further notice. Staff will continue to work.

The <u>Pasquotank Public Safety Building</u> will be closed beginning at 8:00am Tuesday, March 17th to the public. Staff will continue to work and will be available by phone. Purchase permits and concealed handgun renewals are being completed by mail only. New concealed handgun permits will be completed by appointment only and the citizen will be escorted in the building to be fingerprinted. The will also be required to wear a mask provided by the Sheriff's Office.

Pasquotank County Extension Office/4-H has cancelled or postponed all meetings and programs at this time. Beginning April 1, Pasquotank Cooperative Extension will be closed to the public. Staff will be working remotely; however, all staff can be reached by calling our main phone line, 338-3954 and leaving a message for the person you wish to reach. Agriculture agents are available for on-farm visits as needed. Albemarle Regional Health Services (ARHS) began a health screening process effective 8:00 am, March 19^h to enter the Department of Social Services/ARHS facility at 711 Roanoke Avenue.

<u>Pasquotank Department of Social Services</u> - The screening Triage Station is operated by Albemarle Regional Health Services (ARHS) and does include temperature readings for fevers. If you pass the

screening station with no 'red flags', you will be directed to the DSS front desk to conduct as much business as possible in an effort to reduce the risk of transmission and physical contact with staff. If you do not pass the screening station, you will be redirected outside of the building at which time a worker will contact you by phone or meet you outside to conduct business. Services conducted outside will be done with respect to everyone's safety, health and well-being at a minimal distance of 6 feet. With respect to confidentiality, we will seek to obtain as much information as possible by phone or other means and will have an alternate location in the parking lot away from other customers.

Individuals can apply for benefits (Adult Medicaid, Family & Children's Medicaid, Food & Nutrition Services) through the ePass website and options are available to print an application and mail in/drop off if preferred. https://epass.nc.gov/CitizenPortal/application.do.

At this time, the following programs require an in-person application and cannot be completed online:

- Work First Family Assistance/Employment Services
- Including Re-certifications
- Medicaid for Special Assistance

Camden County

The public is encouraged to limit non-essential in-person interaction with Camden County employees and departments when at all possible to help prevent the spread of COVID-19. Citizens are encouraged to use any online services that may be available in addition to communicating with Camden County employees via email or telephone.

Before visiting a Camden County department in person, please explore the website at www.camdencountync.gov or call the desired department to determine if alternative service options are available.

The Planning / Inspections / GIS:

- Limit non-essential in-person contact with employees and departments when at all possible. Employees should wear gloves when handling money or other paper documents.
- Inspectors in office staff should remain behind glass for conversation with contractors.
- Inspectors should have masks available in field for inspections inside occupied houses and should maintain social distance when conversing with workers on site.
- Plats and surveys needing approval and signatures should be left at front desk. Staff can meet in front lobby or outside keeping distance.

The Register of Deeds (ROD) – normal operating hours with the following restrictions:

- Couples may enter to purchase Marriage Licenses but bring no others with them. License must be used in North Carolina within the 60 day period. No refunds will be issued.
- Vault access will be limited to attorney's, their staff, and land surveyors.
- No genealogy research until further notice.
- Citizens with vital record request are encouraged to call ahead of time to verify record is available.

Tax Office:

- Limited number of people in lobby. Appointments should be made in advance if there is a need to talk to staff. Instructions will be posted on door.
- Customers can place payment in the drop box. If paying cash customers should have the exact amount; if paying by check a receipt will be mailed.

Water:

 No offices are closing but limit in office transactions, directing customers to pay online at www.camdencountync.gov, or call 877-885-7968 for card transactions or account information.
 Reconnection and late fees have been discontinued as well as shutting off water for non-payment.

Social Services:

- Camden DSS Office is closed to the public, however, all calls are being received and applications are being accepted, using paper applications.
- If a client needs to provide information to their worker they can utilize the drop box at the front entrance of the agency (make sure you include your name), send an email, fax, or call their worker. Office: 252-331-4787 Fax: 252-335-1009.
- Individuals needing to apply for Medicaid and/or Food Stamps can do so online through the ePass
 website at https://epass.nc.gov; with the exception of Work First (including recertification) and
 Special Assistance/Assisted Living, which requires a face-to-face interview. If a face-to-face
 interview is required clients should call the agency ahead of time so appropriate arrangements can
 be made to accommodate them to ensure the safety of staff.
- For residents that cannot apply online and an application is needed they can call into the agency to
 request one be mailed to them or there will be some for pick up in the DSS reception area. Once
 the application has been completed the drop box at the front entrance can be utilized or mailed to
 the agency.
- If it is necessary to come into the agency, as much business as possible will be done at the front desk to limit contact with staff.

Sheriff's Office:

Beginning Monday March 23rd, the office will be closed to pedestrian traffic for a minimum of two weeks. Sheriff's Office employees will still be working within the confides of the office.

<u>Camden County Senior Center</u> will be closed to the public effective 5:00 PM Monday, March 16th until further notice. All activities and trips are cancelled. The situation will be re-evaluated in two weeks. The Senior Center will be fully cleaned and sanitized before reopening.

<u>Camden Parks and Recreation</u> programs are cancelled until further notice.

The <u>Camden County library</u> will be closed to the public effective 6:00pm on Monday, March 16th until further notice. Staff will continue to work and will be available by phone 9:00am – 5:00pm Monday-Friday (252) 331-2543

<u>South Mills Volunteer Fire Department</u> has taken action to limit meetings and all unnecessary activities They are business as usual with an emphasis on PPE {Gloves, Mask Etc.....}. Officers have been asked to only have the personnel on scene that is necessary to handle the call and cancel all other responding units that are not needed

<u>The Dismal Swamp Visitor Center</u> will be closed to the public until further notice. Visitor Center staff will continue to answer phone calls and emails, etc. and the Center will be thoroughly cleaned.

The <u>Camden County 4-H</u> has temporarily suspended education programming at this time. For the remainder of March this primarily impacts planned 4-H activities. Additionally, with Camden County Schools being closed, all 4-H school enrichment activities are being postponed. The Camden County

Extension Office is suspending walk-in service until further notice, with office visits by appointment only.

<u>NC Forest Service – Camden County</u> office is staffed M-F 8-5 but closed to the public. All Information & Education programs and Prescribed Burning has been cancelled. Burning Permits will be issued online only starting 3/20/20 @ noon.

Elizabeth City

Elizabeth City Fire Department and Police Department effective April 2nd will begin taking temporal temperatures for all shifts upon arrival to work. Staff presenting with temperatures of 100.4° F or higher will be sent home and be required to stay at home until they have been fever free (without fever reducing medication) for 72 hours.

Effective 5:00 p.m. Monday, March 30, 2020, all Elizabeth City-Pasquotank County playgrounds, basketball courts, tennis courts, skate facilities, including the Fun Junktion complex are closed until further notice to reduce the spread of COVID-19 across the county. This announcement is in addition to the previous closing of indoor recreation facilities, centers, restrooms, and league games. All trails, parking areas, green space, and the Knobbs Creek Par 3 Golf Course remain open for individuals and groups of 10 or less.

Effective 8:00 March 26th Mariner's Wharf and Waterfront Park Marinas are closed indefinitely. No vessel of any kind shall be allowed to dock or stay the either locations until further notice. This closure of the marinas is directly related to the COVID-10 State of Emergency.

<u>Elizabeth City Customers Services</u>,. Effective Monday March 23, 2020 - Due to the concerns regarding COVID-19 the Customer Service lobby at City Hall, 306 E Colonial Avenue, is CLOSED. Please use the drivethrough or kiosk to make payments. If you need to apply for new service please call 338-3981 to make an appointment.

<u>Elizabeth City Public Utilities</u> – will suspend utility disconnect until April 30th for all residential customers.

Pasquotank Volunteer Fire Depts/Elizabeth City Fire Dept.

All Fire Departments have reduced the risk for member exposure by limiting the number of firefighters needed to <u>investigate</u> calls. Controlled burns scheduled for training have been postponed.

NC Dominion Power reports:

- Will not shut off power for nonpayment.
- Reconnecting residential customers whose services were shut off.

Postponement of Public Events

• The 2020 TarWheel Cycling Event scheduled for April 18th has been postponed.

- The 2020 NC Potato Festival scheduled for May 15-17 has been postponed.
- The 2020 Bocce Beer and Bites scheduled for April 24 has been postponed.

- The 2020 Camden Heritage Day Festival has been rescheduled for September 12, 2020.
- Paddle for the Border scheduled for May 2nd has been cancelled.

Nursing Homes/Assisted Living Facilities/Home Care: Restricting visitors to facility unless absolutely necessary. Staff is being screened for flu-like symptoms.

<u>Citadel of Elizabeth City</u> is accepting patients! All patients, whether new or returning, will be monitored for 48-hours in an isolation room upon admission. Then arranged a roommate (if applicable) if medically cleared.

<u>Community Home Care and Hospice</u> continues to operate normal hours but office is restricted to visitors and employees are practicing social distancing. Screening patients and employees for risk and symptoms is in place and company is working on a way to teleconference with patients should it be needed.

<u>Albemarle District Jail</u> All professional visits have been suspended. Attorneys will denied entry and are advised to use Juris Link for legal visits. Bondsmen will be denied entry. Paperwork must be conducted prior to entering the jail and completed paperwork will be given to a staff member at the door for processing. All weekenders for Probation & Parole have been suspended. All deliveries (UPS, FEDEX, and USPS) will not be allowed in the building. This policy will be in effect through April 29th.

All Public and Private k-12 Schools are closed until 5/15/2020 in Pasquotank and Camden Counties.

<u>Camden County Schools</u> - Camden County Schools has moved to a working remotely model for most employees as of Friday, March 20. Schools are closed by order of the Governor until May 15, 2020. Schools are open with limited staff, and the public is not to come to the schools unless absolutely necessary. Schools are conducting deep cleaning during this closure period. Students are being instructed through educational materials mostly in an online format. Grab and go lunches are available daily (Monday - Friday) at Grandy Primary School in the cafeteria 11:30AM - 1:00PM. Updated information is provided at https://ccsnc.org/.

Elizabeth City-Pasquotank Public Schools — Schools are closed by order of the Governor until May 15, 2020. Pre-K students will receive instruction via packets from their teacher. Online resources will be posted for parents who have devices available. Parents of K-2 students will receive instructions via packets/online from their child's teacher. Students in grades 3-12 will be assigned a school issued device for virtual instruction unless parents have indicated a school issued device is not needed. Meal Services Change beginning April 3rd – Seven (7) day meal kits will be provided for parents which will be available for pickup on Fridays and will provide food for the children until the next Friday.

- Meals will no longer be served daily after April 3rd.
- Hot lunch will only be served on Fridays at their cafeteria & mobile sites (12 to 2 pm). Shelf stable breakfast will be available during lunch also.
- Meal kits will be available only on Fridays at the three (3) cafeteria sites.

Elizabeth City Regional Airport

The Elizabeth City Regional Airport is open for normal business hours during the COVID-19 pandemic while taking the following necessary precautions for staff and clients.

- The terminal building is closed to the general public (street side),
- Areas of the terminal building are closed limiting access to the rooms necessary for pilots/aircrew to conduct official business,

- Hand sanitizer is available in several areas of the terminal for customer use.

Sentara Albemarle Medical Center

A Triage Tent has been established adjacent to the Emergency Department at Sentara Albemarle Medical Center. This is a collaborative effort of forward preparedness in the event SAMC becomes overwhelmed during this COVID-19 event.

Sentara Albemarle Medical Center has suspended all routine visiting until the transmission of COVID-19 is no longer a threat to patients, staff and community; with some exceptions. Visit www.sentara.com/coronavirus for exception and additional information.

Drive-Thru COVID-19 screening and testing sites have closed until further notice. Citizens with symptoms of COVID-19, are asked to contact their primary care provider or the Sentara COVID-19 Call Center before visiting a Sentara Healthcare location. If it is not an emergency, they are "kindly" asked to remain at home. Sentara (including Sentara Albemarle Medical Center) still has the ability to test high-risk COVID-19 patients inside their hospitals. They ask citizens if they believe they meet the criteria for testing to please call the hospital before arriving to receive proper instructions and also review the testing criteria at www.sentara.com/coronavirus before leaving your home.

The Sentara COVID-19 Call Center (1-833-945-2395) is now open and ready to serve our community. The Call Center will:

- *Operate seven days a week from 9:00am to 7:00pm.
- *Direct callers to appropriate resources based on nurses' evaluations.
- *Answers questions about signs & symptoms based on current CDC guidelines.
- *Provide information on Sentara policies and our COVID-19 response.
- *NOT schedule appointments, provide testing recommendations, or test results.
