State prison officials have now initiated a plan to test the entire offender population; all 31,000. This testing of the population is estimated to require at least 60 days to complete, at a projected cost of more than \$3.3 million. As of July 22nd COVID-19 mass testing has been completed at 39 prison facilities; to include Pasquotank Correctional Institution.

THE OUTBREAK AT ELIZABETH CITY HEALTH & REHAB IS NOW CLOSED. NCDHHS CONSIDERS AN OUTBREAK OVER IF THERE IS NO EVIDENCE OF CONTINUED TRANSMISSION WITHIN THE FACILITY. THIS IS MEASURED AS 28 DAYS AFTER THE LATEST DATE OF ONSET IN A SYMPTOMATIC PERSON OR THE LATEST DATE OF SPECIMEN COLLECTION IN AN ASYMPTOMATIC PERSON, WHICHEVER IS LATER.

- Phase 2 Extension and Mandatory Face Coverings: North Carolina will continue to stay paused in Safer at Home Phase 2 when the governor's current executive order (Executive Order 147), expired on Friday, July 17. The order has been extended and additional three weeks until Friday, Aug. 7. This EO requires the wearing of face coverings in public settings. These actions are needed to slow the spread, which has been on the rise. Additional information regarding Frequently Asked Questions for EO 147 and Requirement for the Use of Face Coverings and Masks is also available.

- ➤ July 28th Governor Cooper issued Executive Order 153 ordering restaurants, breweries, wineries, distilleries, and other establishments which serve alcohol for on-site consumption to cease alcohol sales and service at 11:00 pm and not to resume sales until 7:00 am. This Executive Order goes into effect at 11:00 pm July 31st. Frequently Asked Questions associated with EO153 are also available for viewing.
- Four unemployment programs will remain in place after July 25: <u>State Unemployment Insurance</u>, <u>Pandemic Emergency Unemployment Compensation</u>, <u>Extended Benefits and Pandemic Unemployment Assistance</u>. <u>Learn more about unemployment for individuals</u>.

- ➤ July 23rd Governor Cooper <u>urged Congress to extend the weekly \$600 Federal Pandemic Unemployment</u>
 <u>Compensation benefit</u>, which expired July 25. Those who are owed FPUC for weeks ending April 4 through July 25 will be paid those benefits retroactively. Learn more from the N.C. Division of Employment Security.
- Friday, July 24th Governor Cooper issued an Executive Order returning regulatory authority for skilled nursing facilities to the Secretary of the North Carolina Department of Health and Human Services (NCDHHS). This order applies to nursing homes or skilled nursing facilities, including combination skilled nursing/adult care assisted living facilities. Separate guidance is available for other larger residential care facilities including adult care homes, behavioral health/IDD, intermediate care facilities, and psychiatric residential treatment facilities (PRTF) with seven or more beds, available here. (Facilities with six or fewer beds should refer to "Guidance for Smaller Residential Settings Regarding Visitation, Communal Dining, Group and Outside Activities" available here).
- ▶ PPE for Childcare Centers in the C19 Pandemic: NCDHHS, Division of Child Development and Early Education (DCDEE) will provide each open provider with a delivery of PPE and cleaning supplies. The inventory of supplies expected include touchless thermometers with batteries, 10 cloth face coverings for each child care employee, disposable masks, bleach solution, paper towels, disinfectant wipes, and hand sanitizer. Childcare centers should expect to receive an 8-week supply of these items in multiple shipments starting this week.
- ➤ <u>DCDEE is not requiring families to pay their parent fees for July 2020.</u> The State will make the parent fee payments to open providers as part of the regular subsidy payment for July. Each family will receive a notice by mail informing them of this short-term change.
- Meningococcal Conjugant Vaccine Requirement: There is a new immunization rule to protect students from meningitis takes effect in 2020-21 school year. Effective August 1st a booster dose of meningococcal conjugant vaccine (MenACWY) is required for students entering the 12th grade in public, private or religious schools in North Carolina. Students who do not meet this requirement may not be allowed to attend school until they receive the booster dose.

SCHOOLS

- Camden County Schools Board Of Education announced July 24th that schools will begin the 2020/2021 school year on Plan C, which is 100% remote learning for students for the first nine weeks grading period. Camden Early College High School will begin classes on August 12 and all other schools on August 17. It was also decided that Grandy Primary School will begin the school year with 100% remote learning with a target date of September 8 to transition to Plan B which is a mix of remote and face-to-face instruction with no more than 50% of students in the building at any given time and some strict safety guidelines in place.
- The ECPPS Board of Education adopted the district plan for re-entry on Monday, July 27, 2020, during their regular meeting via livestream. ECPPS will return in August under a hybrid plan which is Plan B, Option F, from the state's Lighting Our Way Forward: North Carolina. The plan provides the district flexibility in determining what best meets the needs of families and the community. ECPPS will use Option F to begin 2020-2021 under a phased in approach. The first nine weeks will include remote learning for students while providing the opportunity for one-on-one assessment of Exceptional Children students, English Language Learners, and Pre-K. - On June 15th, the North Carolina High School Athletic Association (NCHSAA) approved to lift the "dead period" to allow high schools to hold individual conditioning in accordance with the "NCHSAA Reopening Sports/Activities: Summer Guidance. Each high school submitted plans to ECPPS district administration for review and approval to begin conditioning in accordance with NCHSAA guidelines. July 10th Elizabeth City-Pasquotank Public Schools
- ECSU will start and finish the fall semester early in an effort to avoid a potential second wave of the virus in late fall/early winter. This means students will not receive the normal breaks in their academic schedule for which they are typically accustomed. The first day of classes will be on August 11 and classes will be concluded by November 25. There will be on-campus (face-to-face) instruction, hybrid (face-to-face and remote), and off-campus (online) instruction this fall in each academic department. Classes that will be delivered remotely are specifically identified on students' schedules or can be found when they register for their classes. The majority of classes this year will be remote or offered in a hybrid format. For on campus classes, Academic Affairs has worked with each academic department to determine the ideal classroom configuration with appropriate spacing for all classrooms. Larger campus spaces that allow for physical distancing are also being considered. Classrooms will be reconfigured. Plans for New Student Convocation and Winter Commencement at a later date. - Elizabeth City State University 2020 fall athletics have been suspended in cooperation with a decision announced by the Central Intercollegiate Athletic Association (CIAA) on Thursday, July 9, due to safety concerns surrounding COVID-19. The press release issued by the CIAA on July 9th stated the organization's board of directors worked with the Athletic Directors Association (ADA) to conclude that suspending fall athletic competitions was the right decision due to safety concerns related to COVID-19. "The decision is informed by the reality that several CIAA member schools are located in states experiencing dramatic increases in new COVID-19 cases.
- Mid-Atlantic Christian University has developed a comprehensive plan to help maintain the health and safety of her students, staff, faculty, and visitors in the wake of the COVID-19 pandemic and to be prepared for student to live on campus and classes to begin meeting in early August. The semester has been arranged into two 8-week sessions allowing students to take 2-3 courses per session. This will allow for any sudden changes to our ability to operate in person to be handled more easily as each student will only have to shift 2-3 courses to distance learning at once versus 4-6. This arrangement will also include starting and ending the semester earlier meaning students will not receive the normal breaks in their academic schedule to which they are accustomed. Seating in classrooms has been reduced and arranged to maintain the recommended 6' distance between individuals. It will be required to use face masks in our narrow, highly trafficked hallways but face masks will not be required in classrooms unless the instructor chooses.
- ➢ Blood Donors Needed: The American Red Cross is asking for donors of all blood types. Healthy donors can schedule appointments at various weekend locations from July 23 to August 1. This drive comes as the Red Cross has an urgent need for blood donations to prevent blood shortages as hospitals resume surgical procedures and patient treatments that were temporarily paused earlier this spring in response to the COVID-19 pandemic. The Red Cross is testing all blood, platelet, and plasma donations for COVID-19 antibodies, which provides donors insight into whether they have been exposed to this coronavirus. Donors will be able to view their results 7-10 days after donation through the Red Cross Blood Donor App or at RedCrossBlood.org. TESTING

- ➤ COVID-19 testing is available for those meeting criteria by appointment only at local health departments. Residents are encouraged to call their primary care provider for an assessment or information on testing availability before calling the local health department. If someone does not have a primary care provider, ARHS does offer primary care services. All tests will be completed through a curbside screening clinic at the local health department. Testing is available at Pasquotank (252-338-4400) and Camden (252-338-4460) Health Departments on Thursday 1-3 pm. - Updated guidance from NCDHHS <u>Steps for People to Take After COVID-19 Testing</u> (Spanish version: <u>Pasos para seguir después de hacerse la prueba COVID-19</u>) for patients undergoing testing due to symptoms or known or a suspected exposure.
- Nursing Home Testing for COVID-19: The NC Department of Health and Human Services is collaborating with CVS/Omnicare for a one-time COVID-19 testing initiative of all residents and staff in nursing homes. An estimated 36,000 residents and 25,000 staff in over 400 nursing homes in the state will be tested between now and the middle of August.
- ➤ Migrant farmworkers are a high risk group; especially as COVID-19 can spread easily in setting where many people live in close proximity <u>Updated guidance</u> is available for Migrant Farmworkers, their employers, and housing providers to help prevent the spread of disease among workers.

- The Centers for Disease Control and Prevention has updated its list of COVID-19 symptoms to include stuff or runny nose, nausea or vomiting and diarrhea. The full list includes:
 - Fever or chills
 - Cough
 - · Shortness of breath or difficulty breathing
 - Fatigue
 - Muscle or body aches
 - Headache
 - New loss of taste or smell
 - Sore throat
 - Congestion or runny nose
 - Nausea or vomiting
 - Diarrhea

Symptoms appear 2 to 14 days after someone is exposed to the virus and can range from mild to severe. People will experience different symptoms, including those not on the list. In many cases, coronavirus symptoms can be managed at home. People should seek emergency care if they experience the following:

- Trouble breathing
- Persistent pain or pressure in the chest
- New confusion
- Inability to wake or stay awake
- Bluish lips or face

Anyone with symptoms is asked self-isolate at home to avoid spreading the virus to vulnerable populations.

- Albemarle District Jail Effective June 22nd all activities involving on site visitors and bondsman are remained as is due to COVID-19.
 - Attorney may have legal visits with the clients after passing the COVID-19 screening. Attorneys will be
 denied entry if they are unable to pass this screening and will be advised to use Juris Link for legal visits.
 - All Bondsman will be denied entry. Bondsman's paperwork will need to be completed and completed paperwork will be given to a staff member at the door for processing.
 - All deliveries (UPS, FEDEX, and USPS) will not be allowed in the building, a staff member will meet at the door to pick up deliveries.
 - All weekenders coming to report to serve time will be scheduled by their Probation/Parole Officer.
 They will need to contact their Probation/Patrol Office regarding any issues. All weekenders will be screened prior to entering Albemarle District Jail. If they do not pass screening they will be denied. If they are not on time they will be denied. All weekenders that are denied will be reported to their Probation/Parole Officer and will be rescheduled at a later date. No exceptions.

- Below is information regarding the reopening of Elizabeth City Facilities in Phase 2:
 - All tennis courts and (City docks, basketball courts and skate park will be open. (The Splash pad is open). The 25-person restriction will apply in all these areas.
 - All City tot-lots will remain closed.
 - The lobby to the Public Safety Building will be opened limited to three people at a time. Masks must be worn by all visitors.

- City Hall and the customer service area will remain closed to utility customers. Customers requiring new service applications and wanting to see administration must continue to make an appointment. A mask must be worn by the public.
- The Griffith Street satellite office will remain closed for the near future. The payment kiosk and drive- up window is available and the public is encouraged to use these options.
- The Midgett Building will be opened masks must be worn by City staff and their customers.
- All public restrooms will remain closed but may be open (by appointment) for special events that do not exceed 25 people.
- As most organized activities such as baseball, softball, and soccer exceed the 25-person limit, staff will defer opening up the athletic fields until Phase 3.
- The Senior Center will remain closed until gyms are allowed to open.
- **Camden County** facilities/buildings are open in accordance with **Phase 2** allowance.
- ➤ Pasquotank County Monday, July 13th the Pasquotank County Board of Commissioners approved a requirement for face coverings for the public in all county facilities in conjunction with Executive Order 147, which did not apply to local facilities.
 - Pasquotank County will no longer require public interaction by appointment only in the Courthouse and Tax/Register of Deeds/GIS office. The following are the exceptions that will require appointments:
 - Register of Deeds Office Marriage Licenses please call 252-335-4367 for appointments, and
 - Clerk of Courts Office Civil and Estate matters (which always require appointments) please call Civil 331-4642 and Estates 331-4643.
 - The Elections Office Temporary shields have been placed at the Planning and Inspections and Register of Deeds counters to help protect the public and staff. Pasquotank County encourages the public to use the following COVID-19 protective measures:
 - 1. The public is still encouraged to limit non-essential in-person interaction with Pasquotank County employees and departments when at all possible to help prevent the spread of COVID-19. Citizens are encouraged to use any online services that may be available in addition to communicating with Pasquotank County employees via email or telephone.
 - 2. Please explore the Pasquotank County website at <u>www.pasquotankcountync.org</u> or call the desired department to determine if alternative service delivery options are available.
 - 3. All citizens who are experiencing any type of respiratory or flu-like symptoms should not visit any Pasquotank County facility. Please call the relevant department to make alternative arrangements for service provision.

Sentara Albemarle Medical Center:

The following visitor policies will take effect on Thursday, May 7 at noon. This will apply to most Sentara hospitals, including all levels of care and the Emergency Department.

- All non-COVID-19 patients and patients who are not under investigation for COVID-19 may have one visitor.
- Neonatal Intensive Care Unit (NICU) and end-of-life patients may have two visitors.
- Visitors 12 and under are prohibited from the hospital.

All visitors will be screened and have their temperatures taken by a no-touch device before entering the building and will be required to wear a mask. Sentara will provide a community-made mask to visitors who do not have their own. Sentara is taking all necessary precautions to keep our hospitals safe and clean. All areas of the hospitals will be carefully cleaned and disinfected on an ongoing basis. All employees are also masked for your protection.
