THIS IS MEASURED AS 28 DAYS AFTER THE LATEST DATE OF ONSET IN A SYMPTOMATIC PERSON OR THE LATEST DATE OF SPECIMEN COLLECTION IN AN ASYMPTOMATIC PERSON, WHICHEVER IS LATER.





Cases by Age





- Governor Roy Cooper announced Tuesday, November 10<sup>th</sup> that North Carolina's indoor mass gathering limit will be lowered to 10 people in an effort to drive down North Carolina's key COVID-19 metrics. Executive Order 176 will go into effect on Friday, November 13 and will be in place through Friday, December 4. The Order does not change the reduced capacity limits for certain businesses that have already been laid out. For more on this, read the Frequently Asked Questions document.
- Wednesday, November 11<sup>th</sup> The North Carolina Department of Health and Human Services reported the state's highest one day number of COVID-19 cases with 3,119 cases reported. Other key metrics also increased with hospitalizations at 1,246 and the percent of tests that were positive climbing to 7.9 percent.
- COVID-19 Holiday Guidance: As we move toward the holiday season, NCDHHS has developed guidance for the Thanksgiving Holiday, guidance for Black Friday shopping, guidance for fall-related events (English, Spanish), guidance for safer holiday breaks for college students, as well as full guidance for private social gatherings (English, Spanish) and an at-a-glance version (English, Spanish).
- On September 4, Governor Roy Cooper signed into law the <u>Coronavirus Relief Act 3.0</u>, which was passed by the North Carolina General Assembly. The law includes the Extra Credit Grant program to be administered by the North Carolina Department of Revenue. According to the law, the purpose of the program is to "use funds from the Coronavirus Relief Fund to help families with qualifying children in North Carolina by providing economic support to assist with virtual schooling and child-care costs during the COVID-19 pandemic." The grant amount is \$335.00 total for each eligible individual, even if the individual has two or more qualifying children.
  - NCDOR will award a grant to eligible individuals who report at least one qualifying child (age 16 or younger) on their 2019 state individual income tax return; spouses who file a joint state return count as one individual.
  - Eligible individuals who have filed their state return and reported at least one qualifying child do not need to take any action to receive the grant.
  - An individual who did not file a 2019 state tax return solely because the individual's gross income for the 2019 taxable year did not exceed the <u>state filing requirements</u> for the individual's filing status (generally \$10,000 per year if single and \$20,000 per year if married) could apply for the grant through October 15, 2020 under the legislation.
  - An applicant must have met all requirements referenced in the law, including having at least one
    qualifying child age 16 or younger for the 2019 calendar year, to apply for the grant before October
    15, 2020.
  - The NCDOR will send grants as soon as possible, but no later than December 15, 2020
- Beginning Thursday, November 12 at 8:00am, full-service restaurants will be eligible to apply to the Mortgage, Utility and Rent Relief (MURR) Program.
  - Restaurants may only request direct payments for up to four months of rent or mortgage interest restaurants will not be eligible for utility cost reimbursement.
  - Restaurants may request payments for up to \$20,000 per location, for no more than two locations, and must employ fewer than 50 people at the location where they are seeking assistance.
  - Anyone who previously met the eligibility requirements and already submitted an application will not be negatively impacted by these new changes. Among other things, you will not lose your place in line
  - It is expected this program change will quickly lead to the exhaustion of available funds for the MURR program.

- Before applying, <u>review the questions first.</u> Posted are the MURR application questions to expect, so
  you can prepare your answers and gather your documents before starting the actual online
  application.
- The MURR program is for businesses or nonprofit organizations (nonprofits became eligible as of October 27).
- The North Carolina Department of Health and Human Services (NC DHHS) has developed a program to reimburse primary care providers (PCPs) for providing COVID-19 related primary care services (e.g. follow-up care) to uninsured individuals living in North Carolina. The portal for providers to submit the request for reimbursement is live and can be accessed through the <a href="NCTracks secure portal">NCTracks secure portal</a>. - The **Hope4NC** Helpline (1-855-587-3463) connects North Carolinians to additional mental health and resilience supports that help them cope and build resilience during times of crisis. It is available to everyone in North Carolina's 100 counties during the COVID-19 crisis. Hope4NC includes a Crisis Counseling Program tailored for COVID-19, which will provide immediate crisis counseling services to individuals affected by the ongoing COVID-19 public health crisis. This initiative is in partnership with all seven of the state's LME/MCOs and REAL Crisis Intervention Inc. in Greenville. Hope4NC is available 24 hours per day, seven days a week to speak to a live person.



- COVID-19 testing is available for those meeting criteria by appointment only at local health departments. Residents are encouraged to call their primary care provider for an assessment or information on testing availability before calling the local health department. If someone does not have a primary care provider, ARHS does offer primary care services. Testing is available at Pasquotank (252-338-4400) and Camden (252-338-4460) Health Departments on Thursdays 1:00 3:00 pm.
