Item #1 UDO 2007-05-20 Variance/ Charlene Sawyer Cartwright

The applicant Charlene Sawyer Cartwright gave a letter of consent to the Camden County Planning Department granting Don Lee Keaton permission to represent her as she is unable to attend the meeting due to health related issue.

Vice Chairman Duckwall informed Mr. Keaton that only four members are present and that if he chooses to postpone the meeting until a full Board is present, he has the option to do so. Vice Chairman Duckwall also informed Mr. Keaton that as a result of only four members present, any decisions made by the Board must be unanimous in order to pass this Variance. Having been informed, Mr. Keaton stated that he wish to proceed anyway.
