



Be It Further Resolved, an additional meeting of the Camden County Board of Commissioners may be called in months where business necessitates a second meeting and other special meetings including Public Hearings may be called as allowed in the provisions of N.C.G.S. 153A-40 and N.C.G.S. 143-318.12.

Summary:

In response to the request by Commissioners to review the Economic Development Incentive options available to the County, staff contacted Lauren Arizaga-Womble with Twiford Law Firm to revisit the current Economic Development Incentive Grant as well as state statutes. It is important to note that Ms. Arizaga-Womble helped develop the EDIG policy for Camden. She was asked to collect the necessary information and provide a presentation to Commissioners on the options available to the County when a request for Economic Development Incentives occurs. After further review and consideration by Commissioners, EDC members and staff, the attached Incentive Grant provides the best possible grant to qualifying businesses as allowable by statutes with mutually beneficial guidelines. The enclosed grant outlines a small business only plan and as mentioned in the guidelines, these grants do not nullify the ability of the Board to provide an Incentive outside of either of the two grant programs so long as the Incentive complies with state law.

Recommendation:

Approve and adopt new grant program and resolution.

CAMDEN COUNTY SMALL BUSINESS ECONOMIC DEVELOPMENT INCENTIVE PROGRAM

I. **Qualified Properties and Investments**

- **a.** To qualify for any grants under the Camden County (the "County") Small Business Economic Development Incentive Program (the "Program"), all the following conditions must be met by the applicant as determined by the Camden County manager or authorized designee of the County manager (collectively, the "County Official")
 - i. The subject real property must be located within the County (the "Property").
 - **ii.** The subject business or industry must be adding at least three (3) full-time employees or a combination of part-time employees that is the equivalent of at least three (3) full-time employees.
 - iii. The Property must be subject to County ad valorem taxes.
 - **iv.** The applicant must be the record owner(s) of the Property (sometimes hereinafter referred to as the "Applicant" or "Property Owner").
 - **v.** The expenditures in question must be for improvements, renovations, and/or additions to the Property and not for personal property located upon or used in connection with the Property.
 - vi. The total increase in property tax valuation that will result from the improvements, renovations and/or additions to the Property is anticipated, at the time of the application, to exceed Twenty-Five Thousand and No/100 Dollars (\$25,000), and in fact, at the time of payment of any grants under the Program, does exceed that amount.
 - vii. This program shall only apply to businesses with 25 or fewer employees at the time of submitting an application for grant consideration under the Program.
 - **viii.** The Applicant must obtain all appropriate permits from the applicable local government jurisdiction before any improvements, renovations and/or additions, which are intended to be a basis for grants under the Program, are undertaken.

ix. After obtaining the necessary permits, the Applicant must complete an application for grant consideration for a planned improvement, renovation and/or addition to a qualified property. This application shall be in a form and contain information deemed necessary by the County Official and approved by the Board. The application may require attachments such as copies of permits for the project. The Applicant shall indicate the number of employees that will be hired and retained as a result of the planned improvement and related information to determine the Applicant's score as set forth herein. The Applicant may be required to annually verify the number of employees hired and retained in a manner as may be requested by the County Official.

II. <u>Unqualified Properties and Investments</u>

- **a.** Improvements, renovations, and/or additions to Property shall not qualify for grants under the Program for any year in which one or more of the following disqualifying factors exist:
 - **i.** The Property is in violation of any applicable County ordinance and is the subject of an unresolved code enforcement action, as determined by the relevant local government jurisdiction.
 - **ii.** Any Property Owner is delinquent in the payment of any taxes, assessments, fees or other debts owed to the County and such tax delinquency is not resolved to the satisfaction of the County Official.
- **b.** In any of the above factors exist during the grant award period in which the Property Owner would otherwise qualify for a grant under the Program the County Official may:
 - **i.** Withhold the grant funds until such time as the County Official determines a satisfactory resolution has been achieved or
 - ii. The Camden County Board of Commissioners (the "Board") may, in its sole discretion, choose to deny grants for all the grant term or for any year of the grant term for a Property, or improvement, renovation and/or additions to a Property. In this regard, any grants described herein and awarded under the Program shall not become vested rights of any owner(s) of Property, but instead are at the discretion of and are subject to an annual appropriation by the Board. Moreover, no grant awarded under the Program will be paid to any Property Owner that has chosen to accept grants under another County tax based incentive grant program.

III. <u>Scoring</u>

- **a.** The allocation of points in this model is based upon the desire and need for quality jobs, diversification of the economy, the County's need for additional capital investment (and associated property tax revenue), and the County's interest in assisting businesses in good standing.
- **b.** The monetary value of each financial incentive grant shall be calculated as a percentage of annual property taxes paid by the Applicant. For each year of the grant, the company will receive an award based on a percentage of property taxes paid that year. The percentage is determined by the project's score, as detailed below, and the percentage will decrease each of the five years. The County will continue to utilize qualitative criteria outlined in this document and other policy documents to approve, reject, and/or modify the grant amount.
- **c.** If an Applicant receives a minimum score of 40, but less than 70, it will achieve a Level 2 status and may be eligible for a grant based on the percentages set forth below of additional tax revenue generated by the real estate improvement described in the grant application. If an Applicant receives a minimum score of 70, then it will achieve a Level 1 status and may be eligible for a grant based on the percentages set forth below of additional tax revenue generated by the real estate improvement described in the grant application.

IV. <u>Grant Process</u>

a. Any Property Owner which has qualified for incentive grant under the Program may receive said grant over a five (5) year grant award period, subject to the terms and conditions set forth herein.

- **b.** Each individual grant will require a separate contract agreement approved by the Applicant and the County following a properly noticed public hearing.
- **c.** Grant awards shall only be made after the company has paid its annual property tax and presented evidence of compliance with performance measures of the agreement.
- **d.** Each application form shall contractually bind the Applicant to the terms of the Program, and other compliance and verification requirements as may be deemed appropriate by the County Official.
- e. No final commitment by the County will be made until such time as the Board makes a final decision approving or disapproving the incentive grant.
- **f.** The execution of the Application by the County Official evidences that the application has been received and that it appears on its face to be an application qualified for consideration by the Board. This signature in no way indicates final approval of the grant application or any commitment by the County.
- **g.** Under this incentive policy, applicants may qualify for, but are not guaranteed, a financial incentive grant. The County reserves complete discretion in determining which eligible projects warrant a financial incentive grant. The County will use criteria outlined in this document and other policy documents to accept, reject or modify the grant amount. The Board will consider the following factors including but not limited to:
 - i. The number of employees to be hired, wage level, and quality of jobs to be created;
 - ii. The level of capital investment;
 - iii. The community impact created by the project;
 - iv. The business type and standing;
 - v. The location of the Property within the County and the overall need for improvements in that area;
 - vi. The previous condition of the Property to be improved;
 - vii. The nature of the business to be conducted in or on the Property to be improved; and

- viii. Such other matters as the Board may, in its discretion, deem worthy of consideration.
- **h.** The County Official shall submit applications to the Camden Economic Development Commission ("CEDC") for review and recommendation prior to submission for Board approval.
- **i.** All applications that meet the requirements of the program will be submitted for Board approval or disapproval.
- **j.** The County Official shall give written notice to each Applicant of the approval or disapproval of each grant application.
- **k.** Within thirty (30) days after a grant has been approved by the Board, the County and the Applicant shall enter into a written agreement setting forth the terms and conditions of the grant (the "Incentive Agreement") that is satisfactory to the County, in the County's sole discretion. If the Applicant does not enter into the Incentive Agreement within the applicable time period, the Applicant's application and any Board approval shall be deemed null and void and of no further force and effect.
- **I.** If the Applicant does not enter into the Incentive Agreement (as hereinafter defined) within the applicable time period, the Applicant's application and any Board approval shall be deemed null and void and of no further force and effect.
- **m.** After a grant has been approved by the Board, grants in future years may be paid to the Property Owner without the requirement for additional public notice and public hearing, provided; however, that the Property Owner must apply each year to the designated County official in order to receive grants in years following the first grant year. In addition, the Property Owner must be in full compliance with the terms of the Incentive Agreement.
- **n.** The grant funds will be paid to the Property Owner no later than thirty (30) days following the full execution of the Incentive Agreement; provided, however, that all property taxes attributable to the relevant improvements, renovations and/or additions to the Property and any other fees or assessments owed to the County have been paid. However, failure by the County to achieve this projected timeline shall not be a basis for any claim for damages or interest, on behalf of any Property Owner.
- **o.** Economic development incentive grant benefits may not be transferred to another party without the specific written consent of the Board of Commissioners.
- **p.** All incentive grant programs must be inspected and confirmed by a representative of Camden County appointed by the Board of Commissioners or County Manager during the five (5) year grant period as to job retention, property value investment, wages paid and all other performance measures by which the project benefits are

determined. Failure to annually meet the projected agreed upon benchmark evaluation thresholds shall result in a reduction or termination of grant award for that year as set forth in the executed grant agreement.

- **q.** This policy only addresses one form of incentive that the County may offer: financial grant awards determined by property tax amounts. The County may, at its discretion, offer other kinds of incentives to companies in addition to—or instead of—this type of financial incentive.
- **r.** The guidelines for the program shall be subject to periodic review. Changing economic conditions or state incentive programs may cause the Board of Commissioners to modify, amend, or even terminate the program subject to compliance with any industrial or business development incentive grants in effect at that time. However, any project that has been provided an incentive grant prior to any program changes shall continue to receive an annual award for the period of the agreement as long as it remains compliant with the terms of the agreement.




Comprehensive Plan Future Land Use Map


CAMA Future Land Use Map





	All positions are currently filled except the currently funded open position that was somewhat an extra deputy working in the patrol division that came from an inter-agency restructure two years ago. A supervisor position was eliminated two years and that position was moved to the patrol division as a patrol deputy that would work mid shift with the future hopes of garnering another position to make the platoons even with 6 deputies to each platoon.

Bylaws of the Camden County Library Board

Article I – Name

This organization shall be known as the Camden County Library Board located in Camden County, North Carolina.

Article II – Purpose

The Camden County Library Board shall act in an advisory capacity to the Camden County Board of Commissioners and the Camden County Librarian in matters pertaining to the policies, services and operation of the Camden County Library.

Article III – Board Membership

Section I – Requirements to Become a Member

- a. Be a resident of Camden County, North Carolina;
- Apply using the County's standard volunteer form and submit it to the Camden County Board of Commissioners for consideration;
- No immediate family members of County officials may serve on the Library Board;
- No officers of other library related organizations of Camden County may serve on the Library Board with voting rights.

Section II - Responsibilities of Board Members

- a. Attend the Board's quarterly meetings;
- b. Notify the Librarian or Board Chair if unable to attend a meeting;
- c. Assist in interpreting the policies and functions of the Library to the public;
- Encourage in every possible way the development and advancement of the Public Library;
- e. Abide by the policies of the Camden County Library and the East Albemarle Regional Library.

Section III - Composition of Board and Terms of Membership

- The Board shall consist of twelve (12) members with nine (9) chosen from the citizens at large;
- b. One member shall be a sitting Camden County Commissioner appointed by the Camden County Board of Commissioners;

- c. One member shall be County Manager who will serve ex-officio without the power to vote;
- d. One member will be the County Librarian who will serve as the Executive Director of the Board and be ex-officio without the power to vote;
- e. Each member shall be appointed to serve a three (3) year term. Members are eligible to serve an additional three (3) year term, but no one may serve more than two (2) consecutive terms.

Section IV – Resignations, Terminations and Vacancies

- a. Resignations from the Library Board must be in writing;
- Any member may be removed from the Library Board of incapacity, unfitness, misconduct or neglect of duty upon recommendation of the Library Board;
- c. Any member who fails to attend two consecutive meetings of the Board without a valid reason may be replaced. Ex-officio members are excluded.
- d. Any vacancy on the Board shall be reported to the Camden County Board of Commissioners and said body will be responsible for appointing a replacement.

Article IV – Officers

Section I – Officers

- a. Chairperson
- b. Vice-Chairperson
- c. Secretary
- d. Executive Director
- Officers shall be elected at the annual meeting in July and will serve a two (2) year term.
- f. No officer, with the exception of the Secretary The Chairperson, Vice-
 - Chairperson and Secretary, can succeed him/herself to serve a consecutive term.
- g. Officers may be removed for the same reasons noted for general members of the Library Board.

Section II – Duties of Officers

- a. The Chairperson will:
 - 1. Preside at meetings;
 - 2. Authorize standing and special committees and appoint members;
 - Assist the County Librarian in the creation of the Library's annual budget as a member of the Finance Committee;
 - 4. Notify the Camden County Board of Commissioners and the members of the Library Board of vacancies on the Board;

- 5. Generally perform the duties of the presiding office.
- b. The Vice-Chairperson will:
 - 1. Preside at meetings in the absence of the Chairperson;
 - 2. Perform the duties of the Chairperson when the Chairperson is unable to do so.
- c. The Secretary will:
 - 1. Keep a true and accurate account of all meetings;
 - 2. Provide a copy of the minutes to the Executive Director within 30 days of the meeting;
 - 3. Keep a record of attendance for Board meetings;
 - 4. Inform the Chairperson in the event any member is absent from two consecutive meetings.
- d. The Executive Director will:
 - 1. Prepare the agenda for each regular meeting of the Library Board;
 - 2. Collect a copy of the minutes from the Board Secretary;
 - Prepare and distribute by surface mail or email the agenda, minutes, quarterly statistics, finance report and librarian's report;
 - 4. Prepare a draft budget for review by the Board Finance Committee
 - 5. Secure signatures on meeting minutes from the Chairperson and the Executive Director.

Article V - Meetings

Section I - Date, Time and Location of Meetings

- a. The Library Board will meet on the third Tuesday in January, March, April and July and October at 5:15 p.m. The meetings will be held at a location approved by the Board.
- b. The July meeting will be the annual meeting at which Board elections and committee appointments will occur.
- Section II Rules Governing Meetings
 - a. Meetings may be called by the Chairperson and the Executive Director.
 - b. A majority of the members shall constitute a quorum at all meetings of the Board.
 - c. All questions presented for a vote of the Library Board shall be decided by a simple majority of the quorum present.
 - d. Special meetings may be called at the discretion of the Chairman or at the request of three members for the transaction of business as stated in the agenda for the meeting.

e. Robert's Rules of Order, Newly Revised, shall govern in the parliamentary procedure of the Board, in all cases to which they are applicable and in which they are not inconsistent with these bylaws, in which case these bylaws shall govern the proceedings.

Article VI – Committees

Section I – Finance Committee

a. A Finance Committee of two or more members shall be appointed by the Chairperson and shall be composed of those members, the Chairperson and the County Librarian. The Committee shall be responsible for the preparation of an annual budget for presentation to the full board at the March meeting. Upon Board approval, the Library budget request shall be forwarded to the Camden County Board of Commissioners for consideration.

Section II – Other Committees

a. Other committees shall be appointed by the Chairperson as needed.

Article VII - Amendments

These bylaws may be amended at any regular meeting of the Board with a quorum presented by a two-thirds majority vote of the members present, provided that the amendment was stated in the agenda. The bylaws are subject to the final approval of the Camden County Board of Commissioners.

RESOLUTION OF THE CHOWAN COUNTY BOARD OF COMMISSIONERS REQUESTING THE NORTH CAROLINA GENERAL ASSEMBLY TO REPEAL N.C. GEN. STAT § 105-275 (45) EXCLUDING EIGHTY PERCENT OF THE APPRAISED VALUE OF SOLAR ENERGY ELECTRIC SYSTEMS FROM AD VALOREM TAX

WHEREAS, on January 1, 2016 the North Carolina law allowing a thirty-five percent tax credit on renewable energy production systems ended; and

WHEREAS, N.C. Gen Statute § 105-275 (45) still allows the exclusion of eighty percent of the appraised value of solar energy electric systems from local ad valorem tax valuation; and

WHEREAS, in 2017 the Chowan County Planning Board has approved two renewable energy developments to be constructed in Chowan County comprised of solar energy electric systems to encumber 276.07 acres of land; and

WHEREAS, due to N.C. Gen Statute § 105-275 (45) the solar energy electric systems in Chowan County will be assessed at an amount lower than other commercial developments not receiving preferential tax treatment under the statute would be required to pay; and

WHEREAS, Per the Solar Energy Industries Association (SEIA): Published Sep 20th, 2017, Cost to install solar declined 70% since 2010, nationwide, and costs for NC solar energy projects have fallen by 64% over the past 5 years; and

WHEREAS, a community hosting solar energy electric systems should receive the full benefit of such development within its boundaries particularly since solar energy electric systems reduce open space and useable farmland and generate visual and other impacts unwelcome to property owners adjacent to solar energy electric systems; and

WHEREAS, it is apparent that by allowing expiration of the state's thirty-five percent tax credit on renewable energy production systems the North Carolina General Assembly has determined that incentives are no longer necessary to encourage renewable energy development like solar energy electric systems in North Carolina and repeal of N.C. Gen Statute § 105-275 (45) is necessary and appropriate.

NOW THEREFORE. BE IT RESOLVED by the Chowan County Board of Commissioners that:

- Section 1. Chowan County requests that its legislative delegation sponsor and otherwise support legislation to repeal N.C. Gen Statute § 105-275 (45).

Ordinance No. 2017-09-02

An Ordinance Amending the Camden County Zoning Map Camden County, North Carolina

Article I: Purpose

The purpose of this Ordinance is to amend the Zoning Map of Camden County, North Carolina, which was originally adopted by the County Commissioners on December 20, 1993, and subsequently amended.

Article II. Amendment to Zoning Map

The Official Zoning Map of Camden County, North Carolina, which was adopted on December 20, 1993, and subsequently amended, is hereby amended as follows:

The properties currently shown in the Camden County Tax Assessor's Office as PIN 01-7989-03-11-3920, 01-7989-03-12-7111 and 01-7989-03-12-6135 are hereby re-zoned from Highway Commercial (HC) to Basic Residential (R3-1).

Article III. Penalty

- 1. Violations of the provision of this Ordinance or failure to comply with any of its Requirements, including violations of any conditions and safeguards established in connection with grants of variances or Special Use or Conditional Use Permits, shall constitute a misdemeanor, punishable by a fine of up to five-hundred (\$500) dollars or a maximum thirty (30) days imprisonment as provided in G. S. 14-4.
- 2. Any act constituting a violation of the provisions of this Ordinance or a failure to comply with any of its requirements, including violations of any conditions and safeguards established in connection with the grants of variances or Special Use or Conditional Use Permits, shall also subject the offender to a civil penalty of one-hundred (\$100) dollars for each day the violation continues. If the offender fails to pay the penalty within ten (10) days after being cited for a violation, the penalty may be recovered by the county in a civil action in the nature of debt. A civil penalty may not be appealed to the Board of Adjustment if the offender was sent a final notice of violation in accordance with Article 151.568 and did not take an appeal to the Board of Adjustment within the prescribed time.
- 3. This Ordinance may also be enforced by any appropriate equitable action.
 - 4. Each day that any violation continues after notification by the administrator that such violation exists shall be considered a separate offense for purposes of the penalties and remedies specified in this section.
 - 5. Any one, all or any combination of the foregoing penalties and remedies may be used to enforce this Ordinance.

Article IV. Severability

If any language in this Ordinance is found to be invalid by a court of competent jurisdiction or other entity having such legal authority, then only the specific language held to be invalid shall be affected and all other language shall be in full force and effect.

Article V. Effective Date

This Ordinance is effective upon adoption.

Dear Ms. Humphries:

Raftelis Financial Consultants, Inc. ("Raftelis") is pleased to submit this engagement letter to Camden County (County) to perform a water and sewer system development fee study. The new North Carolina House Bill 436 (HB 436) is prompting the County to review its water and sewer system development fees and ensure the fees comply with HB 436. Raftelis is providing this engagement letter to the County to provide assistance with developing cost-justified water and sewer system development fees using methodologies consistent with the methodology described in HB 436.

Project Scope

Based on HB 436, one of three methodologies may be used for calculating impact fees: the System Buy-In Approach, Marginal Incremental Approach, or a Combined Approach.

The Buy-In Methodology is most appropriate in cases where the existing system assets provide extra capacity to provide service to new customers. This approach calculates a fee based upon the proportional cost of each user's share of existing plant capacity. The cost of the facilities is based on fixed assets records and usually includes escalation of the depreciated value of those assets to current dollars. All core assets that provide benefit to the general transmission/collection and treatment systems are typically included, such as water and wastewater treatment plants, water reservoirs (storage tanks), major water transmission mains and wastewater interceptors, and pump/lift stations.

The Incremental Cost (or Marginal Cost) Methodology focuses on the cost of adding additional facilities to serve new customers. It is most appropriate in a situation where existing facilities do not have available capacity to provide service to new customers, and the cost for new capacity can be tied to an approved capital improvement plan (CIP), or where additional capacity is currently being added and costs can be tied to an on-going construction program.

The Combined Cost approach is used in cases where the existing assets provide some capacity to accommodate new customers, but where the CIP also identifies significant capital investment to add additional infrastructure to address future growth and capacity needs.

To calculate the water and sewer system development fees for the County, Raftelis will perform the following tasks:

11.B.a

TASK 1: Project Management and Administration

This task provides for consistent and competent project oversight to ensure all objectives of the study are met efficiently and on schedule.

TASK 2: Data Collection and Review

Raftelis will prepare a detailed data request list that will identify the information needed to complete the study. Examples of data may include current detailed fixed asset information, the current and approved capital improvement plan, existing debt service, capacity in existing or proposed facilities, etc.

Task 3: Data Analysis and Model Development

Raftelis will develop a model which will provide the functionality to determine the cost basis for the water and sewer system development fees, determine the water and sewer capacity supported by the cost basis, and ultimately determine a cost per gallon per day for capacity in core assets. This cost of capacity per gallon per day will be multiplied by the amount of capacity needed to serve each customer, which becomes the basis for the utility's system development fees. The system development fee can be assessed in various ways. For example, one common approach is to scale the system development fee by meter size using demand ratios established by the American Water Works Association. Once all objectives are completed through Task 3, Raftelis will conduct a Webinar to discuss preliminary results. This will give County staff the opportunity to react to, and provide insight on the preliminary results prior to the completion of the study. Raftelis will then make any modifications and finalize the calculation of system development fees.

Task 4: Preparation of Letter Report

Raftelis will document the study's process and findings in a letter report. County staff will be provided an opportunity to review the report prior to it being made final.

Project Staffing and Fees

The project will be staffed by the same personnel who are providing assistance to several other NC communities regarding water and sewer system development fee studies. I will serve as the Project Manager for this project and will be assisted by staff consultants to develop the model.

We propose to complete the scope of work outlined above for fees and expenses not-to-exceed \$18,000. These fees are based on approximately 96 hours of consultant time. These fees reflect the due diligence efforts to ensure the system development fees comply with HB 436. They also reflect the inclusion of a webinar to discuss the preliminary results and a final presentation of our report via webinar to County staff. If you would prefer we present our final report in person, we can do so for an additional not-to-exceed amount of \$2,500.

It is our practice to bill monthly for fees and expenses as they are incurred during a project. Total fees and expenses will be limited to the not-to-exceed amount unless specific approval for an adjustment in scope is received from the County. If actual hours incurred are less than the estimated hours in the work plan, then these savings will be passed on to you.

BY THE COMMISSION: On December 16, 2016, Camden Solar, LLC (Applicant), filed an application seeking a certificate of public convenience and necessity pursuant to G.S. 62-110.1(a) for construction of a 20-MW_{AC} solar generating facility to be located at the southwest corner of the intersection of NC Highway 343 South and Sand Hills Road (Route 1132), Camden, Camden County, North Carolina. The Applicant plans to sell the electricity to Dominion Energy North Carolina (DENC).

Contemporaneously with the application, the Applicant filed a registration statement for a new renewable energy facility. The registration statement included certified attestations that: (1) the facility is in substantial compliance with all federal and state laws, regulations, and rules for the protection of the environment and conservation of natural resources; (2) the facility will be operated as a new renewable energy facility; (3) the Applicant will not remarket or otherwise resell any renewable energy certificates sold to an electric power supplier to comply with G.S. 62-133.8; and (4) the Applicant will consent to the auditing of its books and records by the Public Staff insofar as those records relate to transactions with North Carolina electric power suppliers.

On January 4, 2017, the Commission issued an Order Requiring Publication of Notice.

On February 17, 2017, the State Clearinghouse filed comments. Because of the nature of the comments, the cover letter indicated that no further State Clearinghouse review action by the Commission was required for compliance with the North Carolina Environmental Policy Act.

On March 17, 2017, the Applicant filed a certificate of service stating that a copy of the Application and the related public notice were provided to DENC on January 18, 2017.

Also on March 17, 2017, the Applicant filed an affidavit of publication from the Daily Advance (Elizabeth City, North Carolina) stating that the publication of notice was completed on February 11, 2017. No complaints have been received.

On May 25, 2017, the Applicant filed a letter stating that it intends to use the North Carolina Renewable Energy Tracking System to track RECs or use a tracking system in another state that participates in PJM Interconnection, LLC.

On July 17, 2017, the Applicant withdrew its registration statement.

The Public Staff presented this matter to the Commission at its Regular Staff Conference on July 31, 2017. The Public Staff stated that it had reviewed the application and determined it to be in compliance with the requirements of G.S. 62-110.1(a) and Commission Rule R8-64.

After careful consideration, the Commission finds good cause to approve the application and issue the attached certificate for the proposed solar photovoltaic electric generating facility.

IT IS, THEREFORE, ORDERED as follows:

1. That the application of Camden Solar, LLC, for a certificate of public convenience and necessity shall be, and is hereby, approved;

2. That Appendix A shall constitute the certificate of public convenience and necessity issued to Camden Solar, LLC, for the 20-MW_{AC} solar generating facility to be located at the southwest corner of the intersection of NC Highway 343 South and Sand Hills Road (Route 1132), Camden, Camden County, North Carolina; and

3. That withdrawal of the registration statement is hereby accepted.

The 20 mega-watt (AC) solar power facility is designed to operate as a ground-mount solar photovoltaic system utilizing a single-axis tracker rack or fixed-tilt racking and piling system optimized for clean energy power generation during daylight hours. Depending on final solar module procurement with a target name plate output of 340 Watts per panel, the projected number of solar photovoltaic modules would be approximately 82,500. For the purpose of security a 6' high chain link fence with 1' of three strand barbed wire would encircle the solar photovoltaic system and site access would be limited during construction and system operations and maintenance on site.

All construction materials and equipment will meet federal, state, and county code requirements and electrical power generation equipment will be UL certified. The two parcels identified will also be surveyed for environmental conditions and any major improvements approved by NC DEQ and US Army Corp. of Engineers as required prior to start of construction. In addition to site development, construction, and operations, the Applicant is committed to satisfy and adhere to Camden County UDO Ordinance No. 2017-05-01 and UDO Amendment Ordinance 2017-07-03 as approved by the Board of Commissioners with specific standards adopted to control and regulate solar farm construction and operation in Camden County, North Carolina.

Camden Solar, LLC Decommissioning Plan

Introduction

Camden County Ordinance No 2017-07-03 Chapter 151 contains decommissioning obligations for solar projects. The Applicant/Owner shall have 12 months to complete decommissioning of the solar facility if no electricity is generated for a continuous period of 12 months (not including delay resulting from force majeure). This facility decommissioning plan outlines the process and major activities required to decommission the facility in compliance with the Camden County Ordinance.

Decommissioning process and major activities

Camden Solar, LLC shall be responsible for the solar project decommissioning. At the solar facility end of useful life, or as required by Camden County ordinances, Camden Solar, LLC will obtain the necessary permits and secure an appropriately licensed contractor to decommission the facility. Decommissioning will include the major activities below in compliance with Camden County requirements:

- 1.1 Removal of solar panels, buildings, cabling, electrical components, roads, and any other associated facilities down to 36 inches below grade.
- 1.2 Disturbed earth shall be graded and re-seeded, unless the landowner requests in writing that the access roads or other land surface areas not be restored.
- 1.3 Description of any agreement (e.g. lease) with landowner regarding decommissioning and acknowledgement by land owner, land owner may be held ultimately responsible for decommissioning.
- 1.4 List the type of panels and material specifications being utilized at the site. Material specifications will be provided with Construction Plan prior to start of construction
- 1.5 The identification of the party currently responsible for decommissioning.
- 1.6 Prior to issuance of the Building Permit, approved decommissioning plan obligation shall be recorded in the Camden County Registry of Deeds and shall run with the land until decommissioning is completed.

An appropriately licensed contractor will be secured for decommissioning activities. Erosion and sediment control best management practices shall be installed as required by the authority having jurisdiction. The facility shall be de-energized and disconnected from the grid in coordination with the interconnecting utility. System components shall be disassembled and removed in the appropriate procedure to maintain personnel safety as solar panels remain energized when exposed to sun light. Fencing shall be maintained until the end of decommissioning for security and safety. Materials shall be staged on site and removed from the site by the appropriately licensed contractors as necessary. All materials shall be taken to or disposed of by approved recyclers in compliance with all local, state, or federal regulations.

Recycled and Salvaged materials

The vast majority of system components consists of recyclable materials. Solar panels have a thirty to fifty-year useful life and may be re-used or resold for other projects. Where solar panel manufacturers offer recycling programs, the solar panels shall be disposed removed in coordination with the manufacturers program. Solar panels consist mainly of glass, silicone, and aluminum and may be recycled if dysfunctional or no manufacturer program exists.

Trackers and foundation steel, copper and aluminum conductors, and all other respective recyclable materials will be recycled by an approved recycler.

Inverter stations, combiner boxes, foundation concrete and other miscellaneous materials may not be recycled or may not have disposal programs in place. Any hazardous or non-recyclable materials will be disposed of by appropriately licensed contractors in compliance with local, state, and federal rules and regulations.

Site restoration

The site shall be restored in compliance with Camden County ordinances and the site lease. Coordination with the land owner may require some site improvements to remain, as outlined in the county ordinances. All other improvements will be removed and the site will be restored and re-seeded in compliance with Camden County ordinances.

Schedule

The decommissioning process in its entirety is expected to take 6 - 12 months maximum. Approximately 3 - 6 months will be spent planning, securing the necessary permits, identifying recycling facilities and appropriate disposal facilities for non-recyclable materials, and contracting with the appropriately licensed contractors. Activities on site are expected to take 3 - 6 months maximum.

Plan and Calculations Review



I received a drainage submittal package from Mike Morway with Albemarle & Associates dated October 13, 2017. This is a revised submittal based upon a phone conversation with Mr. Morway on Oct 9. I also inspected the site on Oct 7 and photographs taken then are attached. The boundary of the project extends to the natural ridge line. The upstream end of ditches begins at the edge of the project and flow toward Sand Hill Road and Highway 343. I have little concern about increases in the design stormwater elevation because of the ridge. Additionally, Mr. Morway demonstrated that the probable runoff from the project will decrease because the existing crop field has a SCS curve number of 85 and the proposed condition will emulate meadow/grassland with a curve number of 71. This reduction also complies with the County criteria to reduce the curve number by 4 after development.

Mr. Morway provided a hydraulic analysis of the proposed culverts on the project. The proposed culverts are under maintenance roads throughout the project. His calculations show a reasonable flow rate based upon SCS peak flow rate calculation methods. These flow rates are coordinated with NCDOT which proposes to upgrade road culverts under Sand Hill Road. There is some hydraulic lose through the culverts but because of the proposed culvert sizes the loss is minor, a couple of tenths of a foot of loss. This is a reasonable loss, nothing excessive.

Based upon the review and the factors cited I recommend that the project be accepted with a condition. I ask that the culvert lengths be noted on the plans. If you have any questions concerning these comments, please call me.






