The regular meeting of the Camden County Board of Commissioners was held on Monday September 19, 2011 in the Historic Courtroom, Camden, North Carolina. The following Commissioners were present:

Chairman Sandra Duckwall called to order the September 19, 2011 meeting of the Camden County Board of Commissioners at 7:02 PM.

Item 3.A.- Alex Leary

Mr. Leary came before the Board to give a brief presentation on history of Camden County, and General Isaac Gregory who fought in the Revolutionary War.

Public Hearings

4. A. - Special Use Permit Application (UDO 2011-07-12); Mrs. Wilson L. Forbes, III

Vice Chairman Garry Meiggs made a motion to go into pubic hearing. At 7:27PM, the motion passed 5-0 with Chairman Sandra Duckwall, Vice Chairman Garry Meiggs, and Commissioners Michael McLain, Clayton Riggs, and Randy Krainiak, voting aye; no Commissioner voting no; No absent; and no Commissioner not voting.

Permitting officer Dave Parks came before the Board to provide the following information:

- A special use permit for mining expansion of Forbes mining was requested through the State for 30 acres.
- Finding of facts is evidence.
- Planning Board gave conditions of approval

Edward Hyman of Hyman & Robey Engineering came before the Board to present the following information:

 Mining operation will continue to move forward to the back of the property, while the front of the property that has been mined will be returned to its natural state.

New Business

Item 5.A. - Acquisition of Real Property

County Attorney John Morrison explained that the property in question is owned by Tark, Inc. The offer was \$550,000 for real property, and \$15,000 for personal property. The purpose of the acquisition would be to expand space for the Planning Department and Public Works Department. A discussion was held in closed session, and is now being presented before the Board for vote.

Commissioner McLain expressed that his issue with the acquisition is that the economy is going back into a recession and this may not be the appropriate time to spend money on property.

Chairman Duckwall expressed that she felt that the property is valuable but that she does share the same concerns with Commissioner McLain.

Commissioner Krainiak made a motion to acquire both real and personal property at stated price. At 7:38PM, the motion passed 3-2, with Vice Chairman Garry Meiggs, and Commissioners Clayton Riggs and Randy Krainiak voting aye; Chairman Duckwall and Commissioner McLain voting no; no Commissioners not voting; and no Commissioners not voting.

- Overall expansion and upgrading of the thoroughfare surrounding The Dismal Swamp Welcome Center, Camden Plantation, and the Camden Eco- Industrial Park.
- Pedestrian access will include bicyclists in the plans.
- Master Plan will be made into an electronic copy.
- Looking to get rid of the spray fields by partnering with neighbors to create ponds and use reclaim-water-systems.

- Plans have been submitted to the State for storm water and water quality
- Plans have been submitted to NCDOT for driveway entrance
- Bid documents will soon be submitted for paving the driveway entrance
- Anticipating the final approval in October
- Based on funding information, the main boulevard in the Park will come to "Opportunity Drive", and extend to the back of the lot.

BE IT RESOLVED that Albemarle District Jail facility was originally built on land that was deeded to the Albemarle District Jail Commission, a body of politic, by Deed dates September 4, 1973, recorded in Deed Book 347, Page 99 of Pasquotank County Public Registry, by Pasquotank County.

THE DEED provided "to be used by the said Party of the Second Part (ADJ), so long as the said Party of the Second Part (ADJ) shall use the same for jail or confinement purposes, and when the said Party of the Second Part (ADJ) shall cease to use the said lands described hereinbelow for jail or confinement purposes then the said land shall convert to the Party of the First Part" (Pasquotank County)...

THAT WHEREAS, the said jail or detention facility at the parcel described is no longer being utilized by Albemarle District Jail Commission as a confinement facility.

NOW, therefore, the members of Albemarle District Jail Commission, namely, Camden, Pasquotank, and Perquimans Counties do individually and collectively direct the Albemarle District Jail Commission to reconvey the lands described to the Board of Commissioners of Pasquotank County, a body politic.
