<u>Old Business - Consideration of Ordinance No. 2009-01-01 - An Ordinance of Camden County Homeowner Certification Ordinance</u>

A public hearing was held on February 16, 2009 and comments were received from the public.

The trade's code compliance ordinance will allow testing of any home owner who would like to attempt to install electrical, plumbing, or HVAC systems in new construction, remodels or rehabs.

The property shall be owned by the homeowner, and shall be lived in by the homeowner for minimum of (12) months after completion and Certificate of Occupancy awarded.

This is an attempt to stop unlicensed people from doing work that requires a NC Trade License. There will be a twenty five (25) question test given in each trade to ascertain if the owner has the ability and knowledge to perform to minimum State Building Code. The ability of the owner to act as their own General Contractor will not be affected by this ordinance as North Carolina State Statutes already covers that.

Chairman Philip Faison called for a motion.

The proposition for Ordinance No. 2009-01-01 – An Ordinance of Camden County Homeowner Certification, having no motion in support, the ordinance fails.

<u>Consideration of Ordinance No. 2009-02-01 – An Ordinance Amending the Camden</u> <u>County Code of Ordinances – Privilege License Tax</u>

Per the Board of Commissioners direction, a Business License Ordinance was prepared based on a model ordinance developed through the School of Government. The County Attorney has reviewed the draft and suggested a few minor modifications, which have been included. It appears from research and discussions with the School of Government that approval of the Ordinance does not require a public hearing.

A public hearing was held on February 16, 2009 and comments were received from the public.

Chairman Philip Faison called for a motion.

The proposition for Ordinance No. 2009-02-01 – An Ordinance Amending the Camden County Code of Ordinances – Privilege License Tax, having no motion in support, the ordinance fails.

<u>Consideration of Ordinance No. 2009-02-02 - An Ordinance Amending the Camden County Code of Ordinances – Article 151 Drainage</u>

A public hearing was held on February 16, 2009 and comments were received from the public.

Commissioner Sandy Duckwall made a motion to amend the subdivision ordinance to prevent the duplication or similar naming of subdivisions. The motion passed with Commissioners Melvin Jeralds, Sandy Duckwall, Garry Meiggs, Michael McLain and Chairman Philip Faison voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Commissioner Michael McLain made a motion to approve the recommendation of the Planning Board to amend Article 151.400 to authorize registered North Carolina Surveyors to perform stormwater drainage designs incidental to a subdivision. The motion passed with Commissioners Melvin Jeralds, Sandy Duckwall, Garry Meiggs, Michael McLain and Chairman Philip Faison voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Approved Ordinance No. 2009-02-02 reads as follows:

Ordinance No. 2009-02-02

An Ordinance Amending the Camden County Code of Ordinances

Camden County, North Carolina

BE IT ORDAINED BY THE CAMDEN COUNTY BOARD OF COMMISSIONERS as follows:

Article I: Purpose

The purpose of this Ordinance is to amend the Article 151 of the Camden County Code of Ordinances of Camden County, North Carolina, which was originally adopted by the County Commissioners on December 15, 1997, and subsequently amended and as otherwise incorporated into the Camden County Code.

Article II. Construction

For purposes of this Ordinance, underlined words ($\underline{underline}$) shall be considered as additions to existing Ordinance language and strikethrough words ($\underline{strikethrough}$) shall be considered deletions

to existing language. New language of proposed ordinance shall be shown in italics (italics) and underlined.

Article III. Amend Section 151 as amended of the Camden County Code which shall read as follows:

CHAPTER 151: UNIFIED DEVELOPMENT

§ 151.231 GENERAL.

(E) The name of the subdivision shall not duplicate nor closely approximate the name of an existing subdivision within Camden or Pasquotank County.

§ 151.400 DRAINAGE.

- (A) Stormwater drainage. Each residential/non residential subdivision or commercial site plan shall provide adequate storm drainage certified by a North Carolina registered engineer <u>or a North Carolina Licensed Surveyor</u>, (with <u>proven experience in stromwater drainage</u>) for all areas in the subdivision. A combination of storage and controlled release of stormwater run-off is required. The release rate of stormwater from all developments shall not exceed the ten-year stormwater run-off from the area in its natural state (post-development vs. pre-development). All free-flowing storm drainage systems shall be designed to accommodate the run-off generated by a ten-year design storm or North Carolina Department of Transportation (NCDOT) standards if more restrictive. The following information must be provided:
 - (1) Elevation survey of entire tract with topo lines at one-foot intervals;
 - (2) All culvert inverts (including driveway culverts);
 - (3) Direction of flows;
- (4) Downstream analysis (cross-sections) of drainage way to outlet (creek stream, river and the like);
- (5) Stormwater storage analysis (storing the differential between the outlet ditch capacity at bank full and the 100-year storm event throughout the proposed development area) and show minimum lot elevations:
- (6) Drainage calculations for drainway design within boundaries of proposed subdivision and off-site, if appropriate;
- (7) Show total pre-development and post-development run-off in CFS (cubic feet per second) volume leaving development area;
- (8) Along all existing drainage ways within proposed development areas, swales (minimum 6:1 side slopes) are preferred over traditional ditches. Maintenance easements the width of the swale shall be centered over the swale.
- (9) If swales are not utilized, then all ditches and canals will require minimum of 30 feet of open space from the top of bank on one side or the other (maintenance area); and
- (10) Developer will be responsible for upgrading drainage system to outlet subject to obtaining permission from all property owners adjacent to the watercourse outlet.
- (B) Plans must address maintenance of the drainage system and who will be the responsible party to ensure proper maintenance is performed on the drainage system. The plan will be reviewed and inspected by County Technical Staff members.

JCPC Program Coordinator Charlene Jones reviewed the JCPC Agreement. The Department of Juvenile Justice and Delinquency Prevention Program have offered \$54,639.00 to fund the programs and requires a 20% local match in funds, or \$10,928.00 with a local in kind match of \$8,890.00.

The motion passed with Commissioners Melvin Jeralds, Sandy Duckwall, Garry Meiggs, Michael McLain and Chairman Philip Faison voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

SOUTH CAMDEN WATER & SEWER DISTRICT BOARD OF DIRECTORS

Commissioner Sandy Duckwall made a motion to recess the Board of Commissioners meeting and convene the South Camden Water and Sewer District Board of Directors at 7:38 p.m. The motion passed with Commissioners Melvin Jeralds, Sandy Duckwall, Garry Meiggs, Michael McLain and Chairman Philip Faison voting aye; no Commissioner voting no; no Commissioner absent; and no Commissioner not voting.

Member Michael McLain made a motion to adjourn the South Camden Water and Sewer District Board of Directors meeting at 7:56 p.m. The motion passed with Members Melvin Jeralds, Sandy Duckwall, Garry Meiggs, Michael McLain and Chairman Philip Faison voting aye; no Member voting no; no Member absent; and no Member not voting.

Chairman Philip Faison reconvened the Board of Commissioners meeting.

Commissioner's Report

Commissioner Michael McLain gave a report on a recent trip to Washington, DC with Chairman Philip Faison and County Manager Randell Woodruff on the following:

- Meet with the appropriate representatives for discussion regarding OLF.
- Meet with Walter Jones, Richard Burr's staff, Kay Hagan's staff and dropped by Butterfield's office to talk to his staff.
- Meetings went very well with expressing opposition to OLF and still working on lobbying efforts.
- There is a great deal of money available in a variety of different areas. Commissioner McLain stated he looked into grant information for a Fire Station for South Mills. Fire Chief Tommy Banks is working on a grant application. The new stimulus package approves money for a Fire Station.
- There is potential money for water plant build outs and talked with people regarding the stimulus money.
- Tremendous amount of money for broadband high speed internet for rural counties.
- Attended the National Association of County Officers conference.

(1) Night Commissioner Meeting Per Month

Following discussion, Commissioner Sandy Duckwall stated that logistics had to be worked out before the Commissioners made a decision to hold one (1) night meeting a month.

Commissioner Sandy Duckwall made a motion, that in the interim, both meetings on the first and third Mondays of the month, go back to evening meetings. The motion passed with Commissioners Michael McLain, Garry Meiggs, Sandy Duckwall and Chairman Philip Faison voting aye; Commissioner Melvin Jeralds voting no; no Commissioner absent; and no Commissioner not voting.

Quasi-Judicial Hearings Held by Board of Adjustment

County Attorney John Morrison stated that the Board of Commissioners has the right to delegate quasi judicial hearings to the Board of Adjustment and the Board may consider delegating the CAPS appeal to the Board of Adjustment. Attorney Morrison cautioned that the Board will loose control and other people will be making judicial decisions who are not elected. To delegate the CAPS hearings only, the ordinance will require an ordinance amendment that the CAPS appeals will be administered by the Board of Adjustment.

County Attorney John Morrison advised that if it was the consensus of the Board, not to vote on the amendment tonight, but to direct the Planning Department in consultation with the Attorney Morrison's office to draft an ordinance and have it placed on the agenda.

Commissioner Melvin Jeralds spoke in opposition.

Commissioner Sandy Duckwall suggested that the Board can have separate quasi judicial hearings as needed.

No action was taken.

Closed Session

No closed session was held.

Adjournment

Commissioner Sandy Duckwall made a motion to adjourn the Board of Commissioners meeting.
