

### Message from the Camden County Board of Commissioners



re recognize the importance of keeping our citizens informed and engaged in our community. We hope this will prove to be a valuable resource for you and we welcome your comments on ways we can improve sharing information throughout the community. # Message from County Manager

his has been a very busy year since the last "Citizen News" was published. A number of items have been completed that had been in the que for some time. The liner has been replaced in the South Mills lagoon at a cost of just over \$1M. This was a significant investment; however, it should keep the waste water treatment facility operational for another 20 years.

The Unified Development Ordinance was completed and approved in February. This document is very comprehensive and covers the land use and building codes for Camden County.

The fire at Station 12 damaged the building and destroyed some of the equipment including an ambulance. In mid-July the fire department was able to move back into the station and is now able to respond to local calls again from the Sawyers Creek location.

The budget for this fiscal year was approved by the Board of Commissioners in June without a tax increase. Although there was no tax increase this year, there will be a solid waste fee included in the tax bill. The collections will help offset the rising cost of trash disposal and recycling. The County still pays over half of the cost from the general fund.

And finally we received 2 significant grants totally over \$3M to make improvements to the Commerce Park, Waste Water Treatment Facility in South Mills and Broadband service within the County. These investments will go a long way in making Camden County the most

# **Summary Updates**

### **Primary Care Clinic & Healthcare Practice Opportunities:**

Staff has been working with Chesapeake Regional Healthcare to open the first primary care clinic in Camden Towne Center with a target of September 2019 to be in operation.

### **County Broadband Initiative:**

Eastern Shore Communications received a USDA grant in the amount of \$1.8M earlier this year regarding the planned installation of their network in Camden County.

ESC is in the early stages of implementing its service plan and construction work which is expected to commence in late fall. The County and ESC are now finalizing a co-location agreement permitting the company to construct certain network facilities on the grounds of two County owned water towers.

### **N.C. Rural Ready Sites Program:**

Whitehurst Sand Co. won the award to extend the roadway in the Commerce Park from Opportunity Drive to the rear of the park. Construction is underway with a completion date around mid-August.

### **Emery Advertising/County Economic & Tourism Collateral Material:**

Staff continues to work with Emery Advertising creating a new logo and branding effort in addition to brochures for economic development and tourism.

### **Camden Commerce Prospect Opportunities:**

The County continues it's marketing of the Commerce Park and the adjacent County owned property. WAO Garage continues to work with their designated engineering company regarding site work in preparation for the construction of their building. The owner is engaged with subcontractors for site clearing and lot development. The joint marketing effort with Jones, Lang, LaSalle commercial real estate continues as well. Interest in locating at the Commerce Park is picking up with inquiries from transportation and warehousing companies.

### **Bovd Homes:**

Camden Plantation plans are starting to move forward with almost all required plans and permits being reviewed and approved. This 600 acre plan unit development is for a 18 hole golf course and upwards of 1700 homes with a commercial site. The first phase will be clearing the site for the golf course and club house. Work is on track to start this fall.



Message from the Sheriff

reetings to our fellow Camden County families and friends! It has been a short but very busy eight months since I entered the office as Camden's Sheriff. The office of Sheriff is very demanding, challenging, but most of all, very rewarding as I have the honor to continue to serve our community in the capacity as their Sheriff. We are constantly striving to enhance the efficiency. professionalism, and transparency of this office. I hope everyone has noticed the new graphics of the patrol vehicles we utilize. It is a more modern and sleek look that still regains the reflective appearance at night for safety, and the best thing is, the new design is \$400.00 cheaper than the old! We are also in the process of changing the uniform and how it is worn on a daily basis by the deputies. All deputies that are assigned to road patrol, when change is made, will wear a class A uniform. Our own staff have designed a new shoulder patch for the uniform that will complete our new look. The Sheriff's office investigative unit did a great job back in January by not only solving, but arresting three individuals that committed several break ins, not only in our county, but in neighboring counties as well.

I would like to thank the County Commissioners for our 2019-2020 budget, we did not get everything we asked for, but what we did will help our office tremendously. Included in this year's budget are monies for a canine addition. The canine or K9 program will be a tremendous asset in our toolbox to deter illicit drug crimes in our county. The K9 can also be utilized in searching for missing people. I would like to thank Deputy Austin Browder for his hard work in putting the K9 presentation together for the county commissioners as well as helping develop our K9 program! I would be remiss if I did not thank Sheriff Doug Doughtie of Dare County for the donation of the K9 insert for our patrol vehicle. While I am on the subject of illicit drug use, we have a growing problem in our county with the abuse of opiates, including prescribed medication and the illegal drug heroin. The deputies, along with the help of the K9, can help deter these drugs from entering Camden County, but we can't arrest our way out of this epidemic. Unfortunately, we are averaging about three calls for overdoses per week in Camden County. Our deputies have saved several people from an untimely death by administering Narcan to these individuals. As I stated in my campaign for this office, I have an "open door" for individuals that have an addiction problem with no fear of arrest or ridicule. Our goal here at the Camden Sheriff's office is to provide individuals with addiction issues the best resources available to put them on the road to recovery, which is what I truly believe an addict wants. Please, if you have an addiction problem and are reading this article, stop in and let's talk, I believe we can help you.

Your deputies in Camden not only respond to vehicle related incidents or property and domestic crimes, they often arrive on scene first at medical emergencies. In doing so, our deputies have, on several occasions, deployed the automated external defibrillator or AED, which has aided in the saving of lives! Also a big thank you to Firehouse Subs of Elizabeth City for donating the AED's to this office!

In early May we had our first of many public forums in each voting precinct. These forums give us the platform to inform you, the taxpayer, on what we are doing for you as a law enforcement agency in terms of

# 7th Annual Dismal Day at the Dismal Swamp State Park

hree species of bears inhabit North America. From largest to smallest, they are the polar bear, brown bear (also known as grizzly) and black bear. Of the three, the black bear is by far the most wide-ranging. In fact, these resourceful bears inhabit forests of at least 40 of the 50 states, including all states in the Southeastern U.S.

Watching a bear can be a wonderful experience. As more people live close to their woodland homes, the chances of seeing black bears are rising. The key is to stay at a safe distance and never let bears get into birdseed, garbage or other human food that can lead them into trouble.

**The bear essentials:** Bears must find food to eat, water to drink, safe places

to sleep including winter dens, and survive fierce storms or heat. The females are kept busy raising their cubs in addition to finding food for themselves. Our job is to give bears plenty of space to live and to find their own healthy, natural foods. Their safety and ours depend on how we behave in bear country.

North Carolina and Virginia have the largest reported number of bears between 17,000-20,000.
